

# November Voting Information and Election Endorsements

Dear Friends,

Our municipal elections are on Tuesday, November 2. There are three ways to vote:

- *By mail* (and you must apply for a ballot at [www.MailMyBallotMA.com](http://www.MailMyBallotMA.com) or by calling City Hall at [617-796-1000](tel:617-796-1000));
- *Early in-person at City Hall* from 8:30 a.m. – 5 p.m. on Monday, October 25 – Friday, October 29 and 8:30 a.m. – noon on Saturday, October 30; or
- *In-person on Election Day* from 7 a.m. – 8 p.m. at your usual polling place.

Participation in our political process is vital - please vote!

One of the main issues that is before the City Council is the ongoing effort to completely rewrite our entire zoning code.

During much of 2020, the Zoning and Planning Committee focused on rewriting the residential portion of our zoning code. In the summer of 2020, the city's Planning Department put forward a new draft of the code, including a proposal to eliminate single family-only zoning throughout much, if not all, of the city. Although the residential aspect of the work was "temporarily" suspended at the end of 2020, I fully expect that after the upcoming elections the City Council will continue its efforts to rewrite the entire zoning code, and that proposals to make major changes to the residential portion of the code will again be before the City Council.

That is why this election is so important! It matters who will be considering, drafting, and then voting on these proposed changes to our zoning code. I urge you to vote for the following candidates who will try to solve specific

problems and bring a common-sense, non-ideological approach to our City Council work.

## At-Large City Council Races
